

3. Document Assembly

"It would normally take probably anywhere from an hour to an hour and 15 minutes to create certain documents, and we're creating those documents more in like 10 minutes, which then gives us time to invest into understanding the nuances of the case. And those details that are often missed because we're doing administrative work are the differences between successful outcomes and unsuccessful outcomes."
